

Air Mail Postage Rates—Zone A

3. In Part 1 of Schedule 5 to the Scheme, under the heading "Countries in Air Mail Postage Rate Zones" the list of countries shall be amended by inserting the country names "Ajman", "Fujairah", "Ras al Khaimah" and "Umm al Qaiwain" in the appropriate alphabetical positions.

Air Mail Postage Rates—Zone B

4. In part 2 of Schedule 5 to the Scheme, under the heading "Countries in Air Mail Postage Rate Zones" the list of countries shall be amended as follows:

- (1) The country name "Ceylon" shall be deleted.
- (2) The country names "Bangladesh" and "Sri Lanka" shall be inserted in the appropriate alphabetical positions.

Application of Inland Post Scheme

5. For the headnote and the whole of paragraph 45 of the Scheme, there shall be substituted the following:
"Application of Post Office Inland Post Scheme"

45. The paragraphs specified in Schedule 9 shall apply to postal packets transmitted by post under the provisions of this Scheme, to the extent and subject to the modifications specified in the said Schedule."

6. For the whole of Schedule 9 to the Scheme, there shall be substituted the following:

Schedule 2 (Postal facilities), items 3, and 8 to 20 inclusive.

Schedule 3 (Express delivery services), items 2, and 4 to 7 inclusive.

The reference in paragraph 18(1)(d) to the Post Office Scheme P7/1972 shall be read as a reference to the Scheme and the words in paragraph 18(2) "and paragraph 7 shall apply to parcels so redirected" shall be omitted.

This paragraph shall apply for the purpose only of the application of the other provisions of the Post Office Scheme P7/1972 mentioned in this Schedule to postal packets transmitted under the Scheme.

The reference in paragraph 34(h) to the provisions of the Post Office Scheme P7/1972 as to the return of postal packets shall be read as a reference to paragraph 20 of the Scheme.

The facilities referred to in items 8 to 20 inclusive shall extend to postal packets transmitted under the Scheme without further charge.

The limits of size and weight shall be those specified in the Scheme."

SCHEME P9/1972

Notice is hereby given that the Scheme which follows this note is made under section 28 of the Post Office Act 1969 and will come into operation on 1st October 1972 when surface parcel services to each country of the United Arab Emirates will be established. The Scheme amends the Post Office Overseas Parcel Post Scheme 1971 by making certain alterations to Schedule 1, which sets out the rates of postage on all parcels. Additionally the Scheme provides for the renaming of Ceylon as Sri Lanka, the provision of the parcel service to Bangladesh, the extension of the parcel service to all places in the British Indian Ocean Territory, the withdrawal of the surface parcel service to Madeira via Malta, and the application of the Inland Post Scheme to the Overseas Scheme.

THE POST OFFICE OVERSEAS PARCEL POST AMENDMENT (No. 3) SCHEME 1972

Made 29th September 1972

Coming into operation 1st October 1972

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf hereby makes the following Scheme:

Commencement, citation and interpretation

1.—(1) This Scheme shall come into operation on the 1st day of October 1972 and may be cited as the Post Office Overseas Parcel Post Amendment (No. 3) Scheme 1972.

(2) This Scheme shall be read as one with the Post Office Overseas Parcel Post Scheme 1971 (Post Office Scheme P8/1971) (hereinafter called "the Scheme") as amended by the Post Office Overseas Parcel Post Amendment (No. 1) Scheme 1972 (Post Office Scheme P3/1972) and the Post Office Overseas Parcel Post Amendment (No. 2) Scheme 1972 (Post Office Scheme P5/1972).

(3) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament, and as if the Post Office Act 1953 (as amended) were an Act conferring the power to make this Scheme.

Postage rates for surface parcel services to the countries of the United Arab Emirates.

2. Part 1 of the table of "Rates of Postage on Parcels" in Schedule 1 to the Scheme shall be as follows:

The following entries shall be inserted in their appropriate alphabetical positions:

Bangladesh	0.90	1.30	1.80	2.80	1.25 0.55

Extension of the surface parcel service throughout the British Indian Ocean Territory

3. Part I of the table of "Rates of Postage on Parcels" in Schedule 1 to the Scheme shall be amended as follows:

(1) The entry "Chagos Islands ... 0.80 1.10 1.55 2.40 No service" shall be deleted.

(2) The entry "British Indian Ocean Territory ... 0.75 1.00 1.45 2.15 No service" shall be inserted in the appropriate alphabetical position.

Change of name of Ceylon to Sri Lanka

4. Part I of the table of "Rates of Postage on Parcels" in Schedule 1 to the Scheme shall be amended as follows:

(1) The entry "Ceylon ... 0.90 1.30 1.80 2.75 1.40 0.60" shall be deleted.

(2) The entry "Sri Lanka ... 0.90 1.30 1.80 2.75 1.40 0.60" shall be inserted in the appropriate alphabetical position.

Withdrawal of surface parcel service to Madeira via Portugal

5. Part I of the table of "Rates of Postage on Parcels" in Schedule 1 to the Scheme shall be amended as follows:

(1) The entries "Madeira direct ... 0.75 0.95 1.25 1.90 0.85 0.20" and "Madeira via Portugal (May to August only) ... 0.80 1.00 1.40 2.15 0.85 0.20" shall be deleted.

(2) The entry "Madeira ... 0.75 0.95 1.25 1.90 0.85 0.20" shall be inserted in their place.

Application of the Inland Post Scheme

7. For the headnote and the whole of paragraph 29 of the Scheme, there shall be substituted the following:
"Application of Post Office Inland Post Scheme

29. The paragraphs specified in Schedule 4 shall apply to postal packets transmitted by post under the provisions of this Scheme, to the extent and subject to the modifications specified in the said Schedule."

8. For the whole of Schedule 4 to the Scheme, there shall be substituted the following:

(Post Office Scheme P7/1972)

Paragraph 14 (Postmarks)

Paragraph 18 (Treatment of packets addressed to deceased persons).

The reference in paragraph 18(1)(d) to the Post Office Scheme P7/1972 shall be read as a reference to the Scheme.

The reference in paragraph 18(2) to paragraph 7 of the Post Office Scheme P /1972 shall be omitted, and the additional postage and fees referred to in paragraph 24 of the Scheme shall be payable on each redirected parcel on delivery.

Paragraph 27 (Postal facilities—general).

This regulation shall apply for the purpose only of the application of the other provisions of the Post Office Scheme P7/1972 mentioned in this Schedule to parcels transmitted by post under the Scheme.

Paragraph 34 (Poste restante)

The reference in paragraph 34(h) to the provisions of the Post Office Scheme P7/1972 as to the return of postal packets shall be read as a reference to paragraph 15 of the Scheme.

Paragraph 51 (Trade charge money orders—crossing); paragraph 52 (Trade charge money orders—payment to bankers); paragraph 53 (Payment of out of date money orders).

These provisions shall apply to trade charge money orders used for the remission of trade charges under paragraph 20(2)(g) of the Scheme.

Paragraph 56 (Variation of route).

Schedule 2 (Postal facilities), items 2, 10 to 18 inclusive, and 20.

The facilities referred to in items 10 to 18 inclusive and 20 shall extend to parcels transmitted by post under the Scheme, without further charge, but the additional postage and fees referred to in paragraph 24 of the Scheme shall be payable on the delivery of each parcel re-directed in accordance with Item 11.

Schedule 3 (Express delivery services), Items 2, and 4 to 7 inclusive.

The limits of size and weight in respect of Items 2 and 4 shall be those specified in the Scheme.

ROAD TRAFFIC ACTS

WATFORD BOROUGH COUNCIL

*The Borough of Watford (Watford Heath)
(Prohibition of Waiting) Order 1972*

Notice is hereby given that Watford Borough Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting at any time:

- on the east, north and west side of the access road to Nos. 15-37 Watford Heath between its junction with Watford Heath and its junction with Pinner Road, but excluding the layby opposite the "Royal Oak" public house;
- on the south side of the access road between a point 3 metres east of the boundary between Nos. 26 and 27 Watford Heath and a point 15 metres west of the junction with the access road to Oxhey Grange Playing Fields.

Exemptions will permit waiting for:

- the picking up and setting down passengers;
- loading or unloading goods;
- carrying out essential services related to the road maintenance or the supply of gas, water and electricity.

Details of the proposal are set out in the draft Order which together with the relevant map and a statement of the Council's reasons for proposing to make the Order may be examined during normal office hours at the Town Clerk's Office, Town Hall, Watford.

Objections to the proposal, together with the grounds on which they are made must be sent in writing to the undersigned by 16th October 1972.
