PUBLIC HEALTH ACTS AND CLEAN AIR ACT

EAST STAFFORDSHIRE DISTRICT COUNCIL

CLEAN AIR ACT 1956

The East Staffordshire District Council (Edgehill, Stapenhill, Burton-upon-Trent) Smoke Control (No. 10) Order 1988

Notice is hereby given that the East Staffordshire District Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, as amended, propose to make an Order entitled The East Staffordshire District Council (Edgehill, Stapenhill, Burton-upon-Trent) Smoke Control (No. 10) Order, 1988, declaring the area described in the Schedule hereto to be a Smoke Control Area.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the said Act, if, on any day after the coming into operation of the Order, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £400 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

A copy of the Order and of the map referred to in it may be inspected by any person free of charge at all reasonable times at the Director of Services Department, Town Hall, Burton upon Trent during the period of 6 weeks from 31st March 1988.

Any person who will be affected by the Order may by notice in writing to the Chief Executive and Secretary, Town Hall, Burton-upon-Trent, by 12th May 1988, object to the making of the Order.

Subject to the consideration of any objections duly made, the Order shall come into operation on 30th November 1988.

THE POST OFFICE OVERSEAS PARCEL POST AMENDMENT (NO. 10) SCHEME 1988

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation.

1. (1) This Scheme shall come into operation on 5th April 1988 and may be cited as the Post Office Overseas Parcel Post Amendment (No. 10) Scheme 1988.
- (2) This Scheme shall be read as one with the Post Office Overseas Parcel Post Scheme 1982 (Post Office Scheme P3/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Parcel Post Amendment (No. 1) Scheme 1983 (Post Office Scheme P2/1983), the Post Office Overseas Parcel Post Amendment (No. 2) Scheme 1984 (Post Office Scheme 4/1984), the Post Office Overseas Parcel Post Amendment (No. 3) Scheme 1985 (Post Office Scheme 3/1985), the Post Office Overseas Parcel Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 5/1985), the Post Office Overseas Parcel Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 1/1986), the Post Office Overseas Parcel Post Amendment (No. 6) Scheme 1986 (Post Office Scheme 3/1986), the Post Office Overseas Parcel Post Amendment (No. 7) Scheme 1986 (Post Office Scheme 7/1986), the Post Office Overseas Parcel Post Amendment (No. 8) Scheme 1987 (Post Office Scheme 1/1987) and the Post Office Overseas Parcel Post Amendment (No. 9) Scheme 1987 (Post Office Scheme 3/1987).

COAST PROTECTION ACT 1949

Notice is hereby given that the Purbeck District Council, acting in its capacity as coast protection authority, under subsection (1) of section 5 of the above Act that it proposes to carry out coast protection work as described herein at Durlston Cliff, Swanage.

The work will consist of rock armour protection to the toe of the cliff, rockfill protection to the surface and removal of ground water from the cliff, together with ancillary works.
