Royal Mail Group Limited^(a) by virtue of the powers conferred upon it by Section 89 of the Postal Services Act 2000^(b) and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

- 1. This Scheme shall come into operation on 23rd July 2007 and may be cited as the Royal Mail Group Limited Overseas Parcel Post (Amendment No.11) Scheme 2007.
- 2. This Scheme shall be read as one with the Successor Postal Services Company Overseas Parcel Post Scheme 2001^(c) (hereinafter called "the Scheme"), as amended by the Consignia plc Overseas Parcel Post (Amendment No. 1) Scheme 2001^(d), the Consignia plc Overseas Parcel Post (Amendment No. 2) Scheme 2001^(e), the Consignia plc Overseas Parcel Post (Amendment No. 3) Scheme 2002^(f), the Consignia plc Overseas Parcel Post (Amendment No. 4) Scheme 2002^(g), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 5) Scheme 2003^(h), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 6) 2003⁽ⁱ⁾, the Royal Mail Group plc Overseas Parcel Post (Amendment No. 7) 2003^(j) the Royal Mail Group plc Overseas Parcel Post (Amendment No. 8) 2004^(k), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 8) 2004^(k), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 9) 2005^(l) and the Royal Mail Group plc Overseas Parcel Post (Amendment No. 9) 2006^(m)
- A reference in this Scheme to the Successor Postal Services Company shall be read as a reference to Royal Mail Group Limited.

Explanatory notes

1. Explanatory note 4 to be replaced with "Consignia plc, (registered number 4138203) was the subsequent successor postal services company and it changed its name to Royal Mail Group plc on 4 December 2002 Royal Mail Group plc then changed its name to Royal Mail Group Limited on 2nd April 2007."

Part 2 (Rates of Postage and General Conditions), Section 6 (Prohibition)

- 2. In paragraph 6(2), point (xx) to be replaced with "batteries where they are not posted in their original retail packaging, or are not sealed or are not in good condition;"
- 3. In paragraph 6(2), point (xxii) to be replaced with "postage stamps unless franked or no longer usable for postage purposes and counterfeit currency;"
- 4. In paragraph 6(2), point (xxiv) to be replaced with "infectious substances assigned to category A;"
- 5. In paragraph 6(2), point (xxv) to be replaced with "perishable items;" 6. In paragraph 6(2), point (xxix) to be added, to read "human and animal remains."
