NOTE: The Amendment Scheme which follows this Note is made under section 89 of the Postal Services Act 2000 and amends the Successor Postal Services Company Overseas Parcel Post Scheme 2001. The Amendment Scheme, which comes into force on 31st January 2011, changes certain products and their prices.

ROYAL MAIL GROUP LTD OVERSEAS PARCEL POST (AMENDMENT NO.16) SCHEME 2011

Made 24th January 2011

Coming into operation 31st January 2011

Royal Mail Group Limited (a) by virtue of the powers conferred upon it by Section 89 of the Postal Services Act 2000 (b) and of all other powers enabling it in this behalf, hereby makes the following Scheme:

1. Commencement and citation

1.1 This Scheme shall come into operation on 31st January 2011 and may be cited as the Royal Mail Group Limited Overseas Parcel Post (Amendment No.16) Scheme 2011.

1.2 This Scheme shall be read as one with the Successor Postal Services Company Overseas Parcel Post Scheme 2001 (c) (hereinafter called "the Scheme"), as amended by the Consignia plc Overseas Parcel Post (Amendment No. 1) Scheme 2001 (d), the Consignia plc Overseas Parcel Post (Amendment No. 2) Scheme 2001 (e), the Consignia plc Overseas Parcel Post (Amendment No. 3) Scheme 2002 (f), the Consignia plc Overseas Parcel Post (Amendment No. 4) Scheme 2002 (g), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 5) Scheme 2003 (h), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 6) 2003 (i), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 7) 2003 (j) the Royal Mail Group plc Overseas Parcel Post (Amendment No. 8) 2004(k), the Royal Mail Group plc Overseas Parcel Post (Amendment No. 9) 2005(l) and the Royal Mail Group plc Overseas Parcel Post (Amendment No. 10) 2006(m) and the Royal Mail Group Ltd Overseas Parcel Post (Amendment No. 11) 2007(n) and the Royal Mail Group Ltd Overseas Parcel Post (Amendment No. 12) 2008(o) and the Royal Mail Group Ltd Overseas Parcel Post (Amendment No. 13) 2008 (p) and the Royal Mail Group Ltd Overseas Parcel Post ((Amendment No. 14) 2009 (q) and the Royal Mail Group Ltd Overseas Parcel Post (Amendment No. 15) 2010 (r) and the Royal Mail Group Ltd Overseas Parcel Post

1.3 A reference in this Scheme to the Successor Postal Services Company shall be read as a reference to Royal Mail Group Limited.

2. paragraph 18 of the contents page is referred to as deleted

3. Clause 3(1), "Global Economy Service" and "Global Economy Service parcel" definitions are deleted

4. Clause 3(1), "Global Value Service" and "Global Value Service parcel" definitions are deleted

5. Clause 5(1) is deleted

6. Clause 5(2), the first line is amended by the deletion of references to Global Value Service to read "In the case of outgoing parcels"

7. Clause 5(2)(b) is amended so that "Part 11" is changed to "Part 1"

8. Clause 5(3), is amended to insert the words "are not covered by paragraph 5(2) and/or which" after the words "parcels which" in the first line and by the insertion of the words "in either case" after the words "paragraph 8(1) and" in the second line

9. Clause 6(1)(a)(i) is amended to add the additional words "leaves from the Catha Edulis plant" after "LSD,"

10. Clause 6 (1)(a)(xx) is amended to read "batteries – only dry batteries (for example AA or AAA) in good condition and in their original sealed retail packaging may be despatched. (Batteries from laptops, cameras, mobile phones and similar electronic goods must be removed from the main body of the item and packaged separately, but form part of the same parcel/consignment) and crackers posted to British Forces Post Office addresses where the banger has not been removed"

11. Clause 13(1), the words "(including an a Global Value Service parcel)" are deleted from the first line

12. Clause 18 is deleted

13. Clause 24(2)(a), the words "one Global Value Service parcel and its contents shall not in any event exceed £50, and any" are deleted

14. Clause 24(2A), is deleted

15. Clause 24 (2) a new subsection (d) is added to read "any other parcel not covered by paragraphs (a) and (c) above shall be nil"

16. Clause 24 (8)(a)(i) is amended to read "in the case of an outgoing parcel, within 120 days of the date of posting; or"

17. Clause 24 (14) is deleted

18. Clause 26(1), the words "Global Value Service and" reference are deleted from the first line

19. Clause 28, the sentence "Please note that a proof of delivery is not available on International Global Value and International Global Economy export services." Is deleted and "Please note that a proof of delivery is not available on BFPO parcel services. " is added as a new final sentence

20. Schedule 1 (Rates of Postage on Parcels). Schedule 1 part 1 is deleted and replaced by the following wording:
