N. B.—Since the date of the Order of the House of Commons, the following alterations have been made in the rates of postage set forth in this Return.

British North America.—The postage on the correspondence passing between the United Kingdom and British North America has been altered to 1 s., in lieu of the rates mentioned in Statement No. 1; and the exemption from the internal colonial postage referred to in note to Statement No. 5, is no longer enjoyed by the port of Halifax; the postage on the correspondence to and from that port being now the same as that between all other parts of British North America and the United Kingdom, viz. 1 s.

New Zealand.—The rates of postage on the correspondence conveyed from one port to another in New Zealand (*see* Statement No. 2), and within New Zealand (Statement No. 5), will no longer be leviable under the Imperial Laws, the Post-office in New Zealand having, since the date of the Order of The House, ceased to be subject to the control of the Postmaster-general.

St. Lucia.—A rate of 1 d. the half ounce has been fixed for the correspondence passing between the towns of Castries (the port), and Souffriere, in lieu of the rates stated in No. 5, as the postage charged for conveyance of correspondence in the interior of the West Indies, &c.

Bahama Islands.—The communication between the different islands of the Bahamas has ceased to be under the control of the Postmaster-general, but is maintained by the colonial government, and the correspondence between these islands is therefore exempted from the internal rates given in Statement No. 5.
