TREASURY WARRANT.

WHEREAS by an Act of Parliament, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," certain scales of weight and rates of postage were fixed and made chargeable and payable upon, for, or in respect of, letters transmitted and forwarded by the post, and various regulations were made, and powers were given to the Commissioners of Her Majesty's Treasury, for the purpose of facilitating the transmission of such letters by the post.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury, by an Act, passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office."

And whereas the Commissioners of Her Majesty's Treasury, by a certain Warrant under their hands, bearing date the 29th day of January, 1859, did order and direct that on every letter sent or tendered or delivered in order to be sent by the post between places in the United Kingdom, or by the post of any post town in the United Kingdom, addressed to a person or place within such town or its suburbs, the postage thereof should be prepaid in stamps, and that every such letter should be duly and properly stamped when posted; and that if any letter sent or tendered or delivered in order to be sent by the post between any places in the United Kingdom, or by the post of any post-town in the United Kingdom, addressed to a person or place within such town, or the suburbs thereof, should be posted without any postage being paid thereon in stamps equal to the sum of one penny, every such letter should be detained and opened, and should be returned or given up to the sender thereof, and in the said Warrant further directions were contained relative to letters so sent or tendered.

And whereas it is expedient that the said recited Warrant should be repealed.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said hereinbefore recited Acts, or either of them, and of all other powers enabling us in this behalf, do by this Warrant, under the hands of two of us the said Commissioners, by the authority of the statute in that case made and provided, order and direct that the said recited Warrant of the 29th day of January, 1859, shall be, and the same is, hereby repealed, revoked, and annulled, and that the several regulations, orders, and directions therein mentioned and set forth, and the repeal therein contained of a certain portion of a Treasury Warrant, bearing date the 22nd day of October, 1847, shall from henceforth wholly cease and determine.
