TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do, by this Warrant, under the hands

of two of us, the said Commissioners, order, direct, and declare as follows :—

1. The rates of postage to be henceforth charged by or under the authority of the Postmaster-General (in lieu of those now payable by virtue of a Treasury Warrant, dated the 18th day of March, 1873, which Warrant is hereby repealed), in respect of the sea conveyance of letters, conveyed or delivered for conveyance by post, as mentioned and described in the Schedule hereunder written, shall be the rates of postage which are respectively fixed and specified by and in such Schedule.

2. This Warrant shall come into operation on the first day of October, one thousand eight hundred and seventy-five.

THE SCHEDULE.

RATES of Sea Postage to be charged on Letters, posted in the Countries and Places hereunder in the first Column mentioned, addressed to the Countries and Places hereunder in the second Column mentioned, and conveyed between such Countries and Places respectively (without passing through the United Kingdom), by British Packet-boat, or partly by British and partly by Colonial Packet-boat.
