

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. The rate of postage to be henceforth charged by or under the authority of Her Majesty's Postmaster-General, in respect of postal packets conveyed or delivered for conveyance by post from Peru, in lieu of the rates fixed and specified by and in the Treasury Warrant, dated the tenth September, one thousand eight hundred and seventy-eight, shall be the rates of postage respectively fixed and specified by and in Parts 1, 2, and 3, of the Schedule hereunder written.

2. Part 2 of Schedule No. 1, Part 2 of Schedule No. 2, and Part 2 of Schedule No. 3 of the said Warrant, dated the tenth September, one thousand eight hundred and seventy-eight, are hereby repealed.

3. This Warrant shall come into operation on and as from the day of the date hereof.

PART 1.

RATES OF POSTAGE to be charged and paid in the United Kingdom on Letters posted in Peru addressed to and received in the United Kingdom from Peru.

By any route, the conveyance being by British or French packet, or partly by British and partly by French packet	One shilling.

PART 2.

RATES OF POSTAGE to be charged and paid in Malta, Gibraltar, Cyprus, and at the British Post Offices in Constantinople, Smyrna, and Beyrout, respectively, upon Letters posted in Peru addressed to and received in Malta, Gibraltar, Cyprus, Constantinople, Smyrna, and Beyrout, respectively, by way of the United Kingdom.

	For every half of an ounce in weight, or for any fractional part of half an ounce over and above the first or any additional half an ounce.
By any route or means of conveyance	One shilling and four pence.

PART 3.

RATES OF POSTAGE to be charged on Postal Packets posted in Peru, and addressed to any British Colony or to any Foreign Country not comprised in the General Postal Union, and conveyed via the United Kingdom.

On each Letter.

The like rate or rates of postage as would have been chargeable and payable under Part 1 of this Schedule in respect of such letter if the same had been addressed to the United Kingdom, in addition to the rate or rates of postage (less the British inland rate or rates) which would have been chargeable and payable on such letter if the same had been posted in the United Kingdom, addressed to such British Colony or Foreign Country.
