TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows :—

1. The rates of postage and additional sums for registration to be henceforth charged by or under the authority of the Postmaster-General, in lieu of the rates and sums now payable in respect of postal packets conveyed or delivered for conveyance by post to and from the several countries and places, by the routes and means of conveyance respectively mentioned and described in the Schedules Nos. 1, 2, and 3 hereunder written, shall be the rates of postage and additional sums which are fixed and specified by and in such schedules respectively.

2. All such postal packets as are hereinbefore referred to shall be posted, forwarded, conveyed, and delivered, under and subject to the several regulations, conditions, prohibitions, and restrictions applicable thereto, respectively contained in the aforesaid schedules and in Schedule No. 4 hereunder written.

3. The Treasury Warrants, dated respectively the 23rd day of December, 1875, the 30th day of May, 1876, the 28th day of November, 1876, the 22nd day of March, 1877, the 20th day of April, 1877, the 28th day of April, 1877, the 22nd day of July, 1877, the 4th day of August, 1877, the 26th day of February, 1878, the 25th day of November, 1878, and the 20th day of March, 1879, are hereby respectively repealed as from the date on which this Warrant comes into operation.

4. This Warrant shall come into operation on the first day of July, one thousand eight hundred and seventy-nine.

## SCHEDULE No. 5.

REGULATIONS AND CONDITIONS, &c., as to the posting, forwarding, conveyance and delivery of postal packets, conveyed or delivered for conveyance by post as mentioned and described in the foregoing Schedules Nos. 1, 2, 3, and 4.

PART I.—*General Regulations and Conditions.*

1. Any postal packet posted in the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or at either of the British Post Offices in Constantinople, Smyrna, and Beyrout, respectively addressed to any country or place mentioned in the first column of Part I of Schedule No. 1, or to the United Kingdom may be registered, provided that all rates of postage and additional sums for registration chargeable thereon be fully prepaid.

2. The sender of any registered postal packet, so posted and addressed as aforesaid, may obtain from the addressee of such packet an acknowledgment of the delivery of such packet to such addressee by paying in advance at the time of posting such packet an additional sum of 2½d.

3. There shall not be conveyed or delivered for conveyance by post to any country or place mentioned in the first column of Part I of Schedule No. 1 any postal packet which shall contain either gold or silver money, any jewel or precious article, or any article liable to customs' duties in such countries or places respectively, and any such packet if posted shall be detained and returned or given up to the sender thereof.

4. There shall not be conveyed or delivered for conveyance by post to any country or place mentioned in the first column of Part I of Schedule No. 1, any newspaper or packet of newspapers exceeding four pounds in weight, nor any packet of commercial papers or packet of printed papers exceeding four pounds in weight, nor any pattern or sample packet exceeding one half of a pound in weight, and any such newspaper or packet if posted shall be detained and returned or given up to the sender thereof.

5. There shall not be conveyed or delivered for conveyance by post any pattern or sample packet the dimensions of which shall exceed eight inches in length, four inches in breadth, and two inches in depth, and any such packet if posted shall be detained and returned or given up to the sender thereof.

6. There shall not be conveyed or delivered for conveyance by post, unless by the special permission in any case or class of cases of the Postmaster-General, any postal packet other than a pattern or sample packet, the dimensions of which shall exceed two feet in length and one foot in breadth or depth, and any such packet if posted shall be detained and returned or given up to the sender thereof.

7. There shall not be conveyed or delivered for conveyance by post any postal packet which shall contain anything which might by pressure or otherwise be rendered injurious either to the officers of the Post Office or to the contents of the mail bags, nor any packet of commercial papers, packet of printed papers, or pattern or sample packet, which shall not be securely packed and guarded in such manner as to furnish complete protection against injury to the officers of the Post Office and to the contents of the mail bags; and any such packet if posted shall be detained and returned or given up to the sender thereof.

8. There shall not be conveyed or delivered for conveyance by post any indecent or obscene print, printing, drawing, photograph, lithograph, en-

graving, book, or card, or any other indecent or obscene article, or any letter, newspaper, supplement, publication, packet, paper, or card having thereon or on the cover thereof any words, marks, or designs of an indecent, obscene, libellous, or grossly offensive character; and if anything shall be posted which shall *prima facie* fall within the aforesaid prohibition, it shall be stopped and submitted at the General Post Office in London, to the inspection of an officer duly authorized in that behalf by the Postmaster-General.

9. Any postal packet addressed to and received in the United Kingdom, which shall be re-directed in the United Kingdom to any country or place mentioned in the first column of Part I of Schedule No. 1, shall not be liable to or chargeable with any British postage in respect either of such re-direction or of the re-transmission thereof by post to the country or place to which the same shall be so re-directed.

10. On every postal packet posted in any country or place mentioned in the first column of Part I of Schedule No. 1, addressed to some part of the same country or place, and which shall be re-directed in such country or place, and transmitted by post from thence respectively to the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or to the British offices of Constantinople, Smyrna, or Beyrout, there shall be charged and paid in the United Kingdom, Malta, Gibraltar, Cyprus, and Tangier, or to the British offices of Constantinople, Smyrna, or Beyrout respectively, on the delivery thereof, in addition to any postage charged thereon in respect of the inland service of the country or place in which such packet shall have been posted, the same rate or rates of postage which such packet would have been chargeable with if the same had been originally addressed to the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or to the British offices of Constantinople, Smyrna, or Beyrout; but in the case of a letter of which the postage to its original address within such country or place as aforesaid has been prepaid by means of a postage stamp or stamps valid in the said country or place affixed to or impressed on such letter, the value of such stamp or stamps shall be deducted from the total amount of postage chargeable under this regulation on such letter as aforesaid.

11. The Postmaster-General may, in any case in which he shall consider it just or reasonable so to do, remit any postage made payable by any regulation contained in this schedule.

12. In this Warrant and the schedules thereto, the expression "United Kingdom" means the United Kingdom of Great Britain and Ireland, the Channel Islands, and the Isle of Man.

PART II.—*As to Post Cards.*

13. Post cards bearing an impressed stamp shall be issued by the Postmaster-General for conveyance by post under this Warrant; and the cards so issued, and no others, shall be deemed to be post cards within the meaning of this Warrant.

14. The address, and nothing else, shall be written, printed, or otherwise impressed on the side of the post card which bears the impressed stamp; and no part of the address shall be written, printed, or otherwise impressed across such stamp.

15. Anything (including a letter or communication in the nature of a letter) may be written, printed, or otherwise impressed on the side of the post card which does not bear the impressed stamp.

16. Nothing whatever shall be in any manner attached to a post card except a postage stamp, or stamps in payment of any deficient postage or additional sum chargeable thereon for registration,

or for acknowledgment of delivery, nor shall a post-card be cut or folded, or otherwise altered.

17. If any post card be posted in the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or at either of the British Post Offices in Constantinople, Smyrna, and Beyrout respectively, without the postage chargeable thereon being fully prepaid, such post card shall be forwarded to its address charged with double the amount of the deficient postage.

18. If any post card be posted otherwise than in conformity with the regulations hereinbefore contained, numbered respectively 13, 14, 15, and 16, it shall be detained and returned or given up to the sender thereof.

#### PART 3.—As to Newspapers.

19. The regulations and conditions made and prescribed by a Treasury Warrant, dated the 27th day of December, 1870, shall, in all respects, apply to registered newspapers conveyed or delivered for conveyance by post under this Warrant, as mentioned and described in Schedule No. 1.

20. If any newspaper or packet of newspapers be posted in the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or at either of the British Post Offices in Constantinople, Smyrna, or Beyrout respectively, without any postage being prepaid thereon, or otherwise than in conformity with the regulations for the time being in force applicable to its transmission, it shall be detained and returned or given up to the sender thereof, but if the postage chargeable thereon be partly prepaid, the regulations in other respects being complied with, such packet shall be forwarded to its address charged with double the amount of the deficient postage.

#### PART IV.—Packets of Commercial Papers.

21. In this Warrant and the schedules thereto the expression "Packet of Commercial Papers" shall include all packets consisting of or containing (inter alia) commercial papers, and the expression "Commercial Papers" shall mean and comprise all papers or documents written, or drawn wholly or partly by hand (except letters or communications in the nature of letters, or other papers or documents having the character of an actual and personal correspondence), and shall include all papers and documents of the following kind, viz.:—Papers and documents of legal procedure, deeds drawn up by public functionaries, copies of or extracts from deeds under private seal (and whether written or printed on stamped or unstamped paper), way bills, bills of lading, invoices, and other documents of a mercantile character, documents of insurance companies and other public companies, all kinds of manuscript music, the manuscripts of books and other literary works, and other papers of similar description.

22. Every packet of commercial papers shall be either without a cover (in which case the packet shall be secured by a band), or in an open cover, and in either case so that such band or cover can be easily removed for the purpose of examination.

23. No packet of commercial papers shall contain anything sealed or otherwise closed against inspection, or which shall contain any letter or any communication in the nature of a letter, or anything of the character of actual and personal correspondence written on any part of the packet or the cover thereof (although the same may be open to inspection).

24. If any packet of commercial papers be posted in the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or at either of the British Post Offices in Constantinople, Smyrna, and Beyrout respectively, addressed to any country or

place mentioned in the first column of Part I of Schedule No. 1, or to the United Kingdom without any postage being prepaid thereon, it shall be detained and returned, or given up to the sender thereof, but if the postage chargeable thereon be partly prepaid, such packet shall be forwarded to its address charged with double the amount of the deficient postage.

25. If any packet of commercial papers be posted otherwise than in conformity with the regulations hereinbefore contained, numbered respectively 21, 22, and 23, it shall be detained and returned or given up to the sender thereof.

#### PART V.—As to Packets of Printed Papers.

26. In this Warrant and the schedules thereto the expression "Packet of Printed Papers" shall include all packets consisting of or containing (inter alia) printed papers, and the expression "Printed Papers" shall mean and comprise all articles of the following kinds, not being commercial papers nor trade patterns or samples of merchandise, that is to say:—

- (1.) Printed books, periodicals, literary works, and pamphlets, either stitched or bound, sheets of printed music, visiting cards, address cards, proofs of printing, either with or without the manuscript thereof, circulars, prospectuses, announcements, notices, whether printed, engraved, or lithographed, and notwithstanding that the same may be communications of the nature of a letter, engravings, photographs, when not on glass or in frames containing glass, drawings, plans, maps, and catalogues, and in general all impressions or copies upon paper, parchment, or cardboard obtained by means of printing, lithographing, or any other mechanical process employed for the purpose of printing except the copying press.
- (2.) Anything usually attached or appurtenant to any of the before-mentioned articles in the way of binding, mounting, covering, or otherwise, and anything necessary or convenient for their safe transmission by post which shall be contained in the same packet.

27. Every packet of printed papers shall be either without a cover or in an open cover, and so that the same can be easily removed for the purpose of examination.

28. No packet of printed papers shall contain anything sealed or otherwise closed against inspection, or any letter or any communication in the nature of a letter, written on any part of the packet or the cover thereof (although the same may be open to inspection), or any separate letter, or communication in the nature of a letter, not being a circular within the meaning of these regulations, but any circular may bear the written signature and address of the sender with his trade or profession and the date.

29. If any packet of printed papers be posted in the United Kingdom, Malta, Gibraltar, Cyprus, or Tangier, or at either of the British Post Offices in Constantinople, Smyrna, and Beyrout respectively, addressed to any country or place mentioned in the first column of Part I of Schedule No. 1, or to the United Kingdom, without any postage being prepaid thereon, it shall be detained and returned or given up to the sender thereof, but if the postage chargeable thereon be partly prepaid, such packet shall be forwarded to its address charged with double the amount of the deficient postage.

30. If any packet of printed papers be posted otherwise than in conformity with the regulations hereinbefore contained, numbered respectively 26,

27, and 28, it shall be detained and returned or given up to the sender thereof.

**PART VI.—As to Pattern or Sample Packets.**

31. In this Warrant and the schedules thereto the expression "Pattern or Sample Packet" shall include all packets consisting of or containing (*inter alia*) such articles as constitute entirely trade patterns, or samples of merchandize hereinafter called "Patterns or Samples."

32. No patterns or samples shall be of any intrinsic value or consist of articles or things of a saleable nature, or having a value of their own apart from their mere use as patterns or samples.

33. Patterns or samples shall, when practicable, be placed in covers open at both ends and so that the same may be easily removed for the purpose of examination. Nevertheless, samples of seeds, drugs, or other articles which cannot be placed in open covers may be enclosed in boxes or in bags of linen or other material fastened in such a manner that they may be readily opened so as to enable the officers of the Post Office to satisfy themselves as to the nature of the contents.

34. There shall be no writing upon any pattern or sample packet, or on the cover thereof, except the address of the person for whom it is intended, the name and the trade or profession of the sender thereof, a manufacturers' or trade mark, or number and the price of the articles of which patterns or samples are contained therein, nor shall there be any writing or other thing enclosed in any such packet except the name and the trade or profession of the sender thereof, or manufacturer's or trade mark, or number and the price of the articles of which patterns or samples are contained therein, and any such permitted writing in any such packet may be on labels attached to the patterns or samples.

35. If any pattern or sample packet be posted in the United Kingdom, Malta, Cyprus, Tangier, or at either of the British Post Offices in Constantinople, Smyrna, and Beyrout respectively, addressed to any country or place mentioned in the first column of Part I of Schedule No. 1, or to the United Kingdom without any postage being prepaid thereon, it shall be detained and returned or given up to the sender thereof, but if the postage chargeable thereon be partly prepaid, such pattern or sample packet shall be forwarded to its address charged with double the amount of the deficient postage.

36. If there shall be posted any packet containing a pattern or sample of any intrinsic value, or any article or thing of a saleable nature, or having a value of its own apart from its mere use as a pattern or sample, such packet shall be detained and returned or given up to the sender thereof.

37. If any pattern or sample packet be posted otherwise than in conformity with the regulations hereinbefore contained, numbered respectively 33 and 34, it shall be detained and returned, or given up to the sender thereof.

38. If any pattern or sample packet be posted in Gibraltar addressed to Spain, the Balearic Islands, the Canary Islands, or the Spanish possessions on the northern coast of Africa without the postage chargeable thereon being fully prepaid, it shall be detained and returned or given up to the sender thereof.

*Torpedo Ground in Sand Haven Bay.*

Further notice is given, that the buoy, conical, painted green and white in horizontal bands, and marked Torpedo Mooring Ground, has been replaced in 5 fathoms water, in a line midway between Great Castle Head and Stack Rock, in readiness for the season's torpedo practice.

**CAUTION.**—Mariners are warned not to anchor or pass in shore of the lines joining Great Castle Head high light-house to Stack Rock Fort, and thence to the east extreme of South Hook Fort.
