NOTICE OF INTENDED DISTRIBUTION OF NAVAL PRIZE MONEY.*Department of the Accountant-General of the Navy and Comptroller of Navy Pay, Admiralty, June 17, 1880.*

NOTICE is hereby given to the Officers, Seamen, and Marines, and to all persons interested therein, that the distribution of the slave and tonnage bounties awarded for 18 slaves and the slave dhow "Mahoulli," captured on the 26th November and 6th December, 1878, by Her Majesty's ship "Vestal," will commence on Tuesday, the 29th instant, in the Prize Branch of the Department of the "Accountant-General of the Navy and Comptroller of Navy Pay, Admiralty, New-street, Spring-gardens, S.W."

Agents and other persons holding powers of attorney, prize orders, assignments, or other instruments, by virtue of which they may be legally entitled to claim the share of any captor serving in the above-named ship, are requested to present the same at this office.

Any Officer, Seaman, Marine, or other person who may desire to receive his share from the Collector of Customs or of Inland Revenue within the United Kingdom, is required to intimate the same by letter to be addressed "On Prize Busi-

ness, to the Accountant-General of the Navy and Comptroller of Navy Pay, Admiralty, London, S.W." (enclosing his certificate of service or an attested copy thereof, excepting in the case of Commissioned Officers),—in which letter his own place of residence is to be precisely stated, as well as the place of the nearest Collector of Customs, or of Inland Revenue, from whom it would be convenient to receive such share of prize money.

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all the powers enabling us in this behalf do by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. So much of the Treasury Warrant of the 14th January, 1880, as relates to the rates of postage and additional sums for registration payable in respect of post cards, packets of commercial papers, packets of printed papers, and pattern or sample packets, conveyed or delivered for conveyance by post by French or Netherland packet, to and from the countries and places specified in Part 1 of Schedule No. 1 of that Warrant, is so far as it relates to the conveyance of post cards, packets of commercial papers, packets of printed papers, and pattern or sample packets by French or Netherland packet, hereby repealed.

2. The rates of postage and additional sums for registration to be henceforth charged by or under the authority of the Postmaster-General, in lieu of the rates and sums now payable in respect of post cards, packets of commercial papers, packets of printed papers, and pattern or sample packets conveyed or delivered for conveyance by post by French or Netherland packet, to and from the several countries and places by the route and means of conveyance mentioned and described in the Schedules Nos. 1 and 2, hereunder written, shall be the rates of postage and additional sums which are fixed and specified by and in such Schedules respectively.

3. All such post cards, packets of commercial papers, packets of printed papers, and pattern or sample packets as are hereinbefore referred to in Clause 2 shall be posted, forwarded, conveyed, and delivered under and subject to the several regulations, conditions, prohibitions, and restrictions applicable thereto, respectively contained in the Schedules Nos. 1 and 2, hereunder written, and in Schedule No. 4 of the Treasury Warrant of the 29th May, 1879.

4. This Warrant shall come into operation on the 1st day of July, 1880.
