**TREASURY WARRANT.**

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. All Treasury Warrants at any time heretofore made relating to the conveyance by post of postal packets (which term in this Warrant means and includes all letters, post-cards, newspapers, packets of commercial papers, packets of printed papers, and pattern or sample packets), between the United Kingdom and the West Indian Colonies of Barbadoes and St. Vincent (of the Windward Islands), and also between any British Colony or Foreign Country and the West Indian Colonies of Barbadoes and St. Vincent (of the Windward Islands), are hereby annulled to the extent to which such Warrants respectively relate to the several matters aforesaid.

2. The rates of postage and additional sum for registration now chargeable and payable by the authority of the Treasury Warrant of the 29th day of May, 1879, or the schedules thereunder written on postal packets conveyed or delivered for conveyance by post from or to Jamaica, to or from any other country or place, and all regulations and conditions as to the posting, forwarding, conveyance, and delivery of postal packets conveyed or delivered for conveyance by post now in force and applicable thereto shall extend and apply to all postal packets conveyed or delivered for conveyance by post from or to the West Indian Colonies of Barbadoes and St. Vincent (of the Windward Islands), to or from any other country or place, in the same way as if the West Indian Colonies of Barbadoes and St. Vincent (of the Windward Islands) had been named in such before-mentioned Warrant of the 29th day of May, 1879, or the schedules thereunder written.

3. This Warrant shall come into operation on the first day of September, 1881.

**GENERAL ORDER** of the Local Government Board. Suspension in part of General Order: Medical Officer's Fees:—

Halifax Union.

To the Guardians of the Poor of the Halifax Union, in the West Riding of the county of York;—

And to all others whom it may concern.

WHEREAS the Poor Law Commissioners, by a General Order bearing date the twenty-fourth day of July, one thousand eight hundred and forty-seven, made certain rules and regulations relating to the administration of relief to the Poor within certain Unions, including the said Halifax Union; and by Article 182 of the said Order, provision was made for the payment of special fees to Workhouse Medical Officers in certain cases;

And whereas it is expedient to suspend, as hereinafter mentioned, the operation of the Article
