# TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts, or any of them, and of all other powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare, as follows:—

## Definitions.

J. In this Warrant

The expression "United Kingdom" includes the Channel Islands and the Isle of Man.

Letters-Rates of Postage.

2. On every letter transmitted by post between the United Kingdom and Queensland wholly by Sea by Colonial Contract Packet Boat via Torres Straits there shall be charged and paid (in lieu of any rates now payable) for every half of an ounce in weight of such letter or fractional part of half an ounce in weight a rate of postage of four pence.

Post Cards - Rates of Postage.

3. On every post card transmitted by post between the United Kingdom and Queensland wholly by sea by Colonial Contract Packet Boat via Torres Straits there shall be charged and paid a rate of postage of two pence.

Application of Provisions of other Warrants.

4. All such letters and post cards as are hereinbefore referred to shall, subject to the provisions of this Warrant, be posted, forwarded, conveyed, and delivered under and subject to the provisions of the Treasury Warrant of the 17th December, 1888, and of any other Treasury Warrant now or for the time being in force applicable thereto.

5. This Warrant shall come into operation on the first day of August, one thousand eight

hundred and eighty-nine.
