THE SEYCHELLES AND THE UNITED KINGDOM, FRANCE, &c.  
TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf do by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us the said Commissioners, order, direct, and declare as follows:—

1. From and after the date when this Warrant comes into operation, the expression "Mauritius" in the Warrant of the Commissioners of Her Majesty's Treasury, dated the 11th day of March, 1859, relating to the transmission of Parcels between the Mauritius and the United Kingdom, and certain other places, shall be construed to mean and include the Seychelles Islands.

2. This Warrant shall come into operation on the first day of April, one thousand eight hundred and ninety.

ORDER of the Local Government Board under the District Auditors Act, 1879: Assignment of Duties and District:—

Essex Audit District.

To Lawrance Hargreaves Wraith, of West View House, Ilkley, in the County of the West Riding of Yorkshire, District Auditor:—

To the Guardians of the Poor of the several Unions named in the First Schedule to this Order;—

To the Overseers of the Poor of the several Parishes comprised within the said Unions respectively;—

To the Highway Boards for the Highway Districts named in the Second Schedule to this Order;—

To the Port Sanitary Authority for the Port of Harwich;—

To the Authorities referred to in Article I (5) of this Order;—

And to all others whom it may concern.

WHEREAS by Section 4 of "The District Auditors Act, 1879," it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act;

And whereas the said Lawrance Hargreaves Wraith is a District Auditor duly appointed under the provisions of the Statutes in that behalf:

Now therefore, We, the Local Government Board, hereby certify the appointment of the said Lawrance Hargreaves Wraith accordingly, and hereby Order and Prescribe as follows:—

ARTICLE I. It shall be the duty of the said District Auditor, from and after the tenth day of March, one thousand eight hundred and ninety, to audit the Accounts of the following Authorities and their Officers; namely,—

(1.) The Guardians of the Poor of the several Unions named in the First Schedule to this Order.

(2.) The Overseers of the Poor of the several Parishes comprised in the said several Unions.

(3.) The Highway Boards for the Highway Districts named in the Second Schedule to this Order.

(4.) The Port Sanitary Authority for the Port of Harwich.

(5.) The several other Authorities for the time being whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said Unions.

(6.) Such of the other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within one or more of the said Unions, as We may by Order under Seal hereafter prescribe.

ARTICLE II. The said District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority, in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and Orders.

ARTICLE III. The District in which the said Lawrance Hargreaves Wraith shall, from and after the said tenth day of March, one thousand eight hundred and ninety, act as Auditor, and
