From and after the date when this Warrant comes into operation, the expression "Germany" in all Warrants of the Commissioners of Her Majesty's Treasury relating to the transmission of Parcels between the United Kingdom and Germany shall be construed to mean and include Heligoland, and such Warrants shall be read and construed as if Heligoland had been expressly mentioned therein.

3. This Warrant shall come into operation on the first day of October, one thousand eight

hundred and ninety.

And whereas by Section 27 of the same Act it is enacted that the Confirming Authority may by Order prescribe the Forms of Advertisements and Notices under Part I of that Act; and that it shall not be obligatory on any persons to adopt such Forms, but the same, when adopted, shall be deemed sufficient for all the purposes of that part of the s id Act:
