REDUCTION OF LETTER POSTAGE.

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts, or any of them, and of all other powers enabling us in this behalf, do by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same) and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

Definition.

1. In this Warrant the expression "United Kingdom" includes the Channel Islands and the Isle of Man.

Rates of Postage.

2. On every letter transmitted by post between the United Kingdom and Bermuda there shall be charged and paid (in lieu of any rates now payable) for every half of an ounce in weight of

such letter, or fractional part of half of an ounce in weight, a rate of postage of two pence half-penny.

Unpaid and insufficiently prepaid Letters.

3. Any letter posted in the United Kingdom addressed to Bermuda, or posted in Bermuda addressed to the United Kingdom, upon which the postage chargeable under this Warrant is wholly or in part unpaid, shall be charged with double the amount of the deficient postage.

Application of Provisions of other Warrants.

4. All such letters as are hereinbefore referred to shall, subject to the provisions of this Warrant, be posted, forwarded, conveyed, and delivered under and subject to the provisions of any Treasury Warrant now or for the time being in force applicable thereto.

Commencement of Warrant.

5. This Warrant shall come into operation on the first day of October, one thousand eight hundred and ninety-one.

REDUCTION OF POSTAGE ON LETTERS AND POSTCARDS TO COLONIES AND FOREIGN COUNTRIES.

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts, or any of them, and of all other powers enabling us in this behalf, do by this Warrant, made on the representation of Her Majesty's Postmaster-General and under the hands of two of us the said Commissioners, order, direct, and declare as follows:—

Definition.

I. In this Warrant—

(1.) The expression "United Kingdom" includes the Channel Islands and the Isle of Man.

(2.) The expression "British Colonies of Australasia" includes New South Wales, Victoria, South Australia, Western Australia, Queensland, Tasmania, New Zealand, British New Guinea, and the Fiji Islands.

Rates of Postage.

LETTERS.

2. On every letter transmitted by post from the United Kingdom to any other country or place (except those places in South Africa which are served by way of the Cape Colony or Natal), there shall be charged and paid (in lieu of any rates now payable) for every half of an ounce in weight of such letter or fractional part of half of an ounce in weight a rate of postage of two pence halfpenny.

POSTCARDS.

3. On every Postcard transmitted by post from the United Kingdom to any other country or place to which such cards are now transmissible, under the authority of any Warrant or Warrants of the Commissioners of Her Majesty's Treasury, there shall be charged and paid (in lieu of any rates now payable) a rate of postage of one penny.

Reply Post Cards.

4. On every Reply Postcard transmitted by post from the United Kingdom to any other country or place to which such cards are now transmissible, under the authority of any Warrant or Warrants of the said Commissioners or to the British Colonies of Australasia, there shall be charged and paid (in lieu of any rates now payable) a rate of postage of two pence.

Unpaid and insufficiently prepaid Letters.

5. Any letter posted for transmission under the authority of this Warrant, upon which the postage chargeable thereon is wholly or in part unpaid, shall be charged with double the amount of the deficient postage.

Application of Provisions of other Warrants.

6. All such letters and postcards as are hereinbefore referred to shall, subject to the provisions of this Warrant, be posted, forwarded, conveyed, and delivered under and subject to the provisions of any Treasury Warrant now or for the time being in force applicable thereto.

Commencement of Warrant.

7. This Warrant shall come into operation on the first day of October, one thousand eight hundred and ninety-one.

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—the cowsheds at No. 81, Brady-street, Bethnal Green, in the county of London, in the occupation of Mr. Benjamin Wisbey,—which was declared by Order of the Board dated the fourteenth day of September, one thousand eight hundred and ninety-one, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-sixth day of September, one thousand eight hundred and ninety-one.

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—the whole of the fields, premises, and buildings known as Raynes Park Farm, in the county of Surrey, in the occupation of Mr. Harry Partridge, of Haydon's-lane, Wimbledon,—which was declared by Order of the Board dated the twenty-second day of July, one thousand eight hundred and ninety-one, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-sixth day of September, one thousand eight hundred and ninety-one.
