TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do, by this Warrant made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us the said Commissioners, order, direct, and declare as follows:—

1. From and after the date when this Warrant comes into operation, Parcels posted in and transmitted by post from the United Kingdom to Tunis, via France, shall be subject to the rates of postage and provisions respectively specified and contained in the Warrant of the Commissioners of Her Majesty's Treasury, dated the twenty-second day of October, one thousand eight hundred and eighty-nine, and so much of the Warrant of the said Commissioners, dated the tenth day of December, one thousand eight hundred and eighty-seven, as relates to Parcels so transmitted, shall be repealed.

2. From and after the date when this Warrant comes into operation, Parcels transmitted from any British colony to Tunis, via the United Kingdom and France, shall be subject to the

rates of postage respectively specified in the first schedule and to the provisions contained in the Warrant of the said Commissioners, dated the fourteenth day of February, one thousand eight hundred and eighty-nine, so far as such provisions are applicable to Parcels transmitted at the rates mentioned in the said schedule, and so much of the second schedule of the last-mentioned Warrant as relates to Parcels so transmitted, shall be repealed.

3. This Warrant shall come into operation on the first day of January, one thousand eight hundred and ninety-two.

TENDERS FOR LOANS ON TREASURY BILLS.

1. THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Monday, the 21st instant, at one o'clock, for Treasury Bills to be issued under the Act 40 Vic., cap. 2, to the amount of £1,500,000.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 28th December, 1891, and will be payable at three months, or six months, or twelve months, after date (at the option of the persons tendering), viz. :—on the 28th March, or 28th June, or 28th December, 1892, respectively.
